## 1. General Provisions

1.1 These admission rules (hereinafter referred to as the Rules) determine the procedure for admission of students to educational programs of higher and postgraduate education at the Kazakh-American Free University (hereinafter referred to as the University).

1.2 Persons with general secondary, technical and vocational, post-secondary, higher education are admitted to study at the University.

1.3 The formation of the student contingent of the University is carried out by placing an educational grant of higher education at the expense of the republican budget and the local budget, as well as paying for education at the expense of citizens' own funds and other sources.

## 2. Regulations

2.1 Rules for awarding an educational grant for paying for higher or postgraduate education with the award of a "bachelor" or "master" degree (hereinafter referred to as the Rules for awarding), *approved by the Decree of the Government of the Republic of Kazakhstan dated January 23, 2008 No. 58 (as amended and supplemented as of August 6, 2021 No. 539);*


2.2 State educational order for the training of specialists with higher education in educational organizations financed from the republican budget for the 2022-2023 academic year, *approved by the Decree of the Government of the Republic of Kazakhstan dated April 20, 2021 No. 253 (as amended and supplemented as of March 11, 2022 city No. 120);*

2.3 The State educational order for the training of personnel with higher education for the 2022–2023 academic year in the context of groups of educational programs, *approved by order of the Minister of Education and Science of the Republic of Kazakhstan dated July 2, 2021 No. 316 (as amended and supplemented as of September 22, 2021 No. 483);*

2.4 The Model Rules for Admission to Education in Educational Organizations Implementing Educational Programs of Higher and Postgraduate Education (hereinafter referred to as the Model Rules), *approved by Order of the Minister of Education and Science of the Republic of Kazakhstan dated October 31, 2018 No. 600 (as amended and supplemented as of November 5, 2021 No. 554);*

2.5 of the Rules for conducting unified national testing and the provision of public services "Issuance of a certificate of passing a unified national testing" (hereinafter - the Rules, 204), *approved by order of the Minister of Education and Science of the Republic of Kazakhstan dated May 2, 2017 No. 204 (as amended and supplemented as of April 13, 2021 No. 162);*

2.6 The List of groups of educational programs that determine the socio-economic development of the village, which provides for a quota for admission to organizations of higher and postgraduate education of the Republic of Kazakhstan,

*approved by order of the Minister of Education and Science of the Republic of Kazakhstan dated May 30, 2019 No. 247;*

2.7 The size of the admission quotas for admission to study at educational organizations implementing educational programs of technical and vocational, post-secondary and higher education, *approved by the Decree of the Government of the Republic of Kazakhstan dated February 28, 2012 No. 264 (as amended and supplemented as of April 21, 2021 No. 256);*

2.8 Guidelines for the compliance of related groups of educational programs of higher education and specialties of technical and vocational, post-secondary education (hereinafter referred to as the Guidelines), *approved by order of the Minister of Education and Science of the Republic of Kazakhstan dated April 1, 2019 No. 134;*

2.9 The Rules for awarding children and youth aged from fourteen to twenty-nine years old with a distinction for their patriotism and active citizenship, *approved by the Decree of the Government of the Republic of Kazakhstan dated April 24, 2020 No. 249 (as amended and supplemented as of May 14, 2020 No. 296) .*

### **3. The Procedure for Admission to the University for Undergraduate Educational Programs**

3.1 The University accepts persons with general secondary, technical and vocational, post-secondary, higher education.

3.2 To participate in the competition for the award of an educational grant of higher education at the expense of the republican budget or the local budget and (or) enrollment in paid education, persons with secondary, technical and vocational or post-secondary education are allowed, with the exception of those entering related areas of training of higher education personnel, providing for shortened terms of study, who passed the UNT and scored on its results:


- in the field of "Pedagogical Sciences" - at least 75 points;
- in the direction of training "Law" - at least 75 points;
- for other educational programs - at least 50 points.

At the same time, for each subject of the UNT and (or) a creative exam, you must score at least 5 points.

To participate in the competition for the award of an educational grant of higher education at the expense of the republican budget or the local budget and (or) enrollment in paid education in related areas of training of higher education personnel, providing for reduced training periods, persons with technical and vocational, post-secondary education who have completed UNT and scored on its results:

- in the field of "Pedagogical Sciences" - at least 35 points;
- for other educational programs - at least 25 points.

At the same time, for each subject of the UNT and (or) a creative exam, you must score at least 5 points.

3.3 Persons who have certificates of international standardized tests SAT, ACT, IB participate in the competition for the award of an educational grant and (or) are enrolled in universities for a paid department, in accordance with the scale for transferring points, according to **Annex \_ one** to these Admission Rules . At the same time, the results of the SAT subject are converted into UNT points, provided that the profile subjects match.

3.4 The University, in accordance with subparagraph 6) of paragraph 2 of Article 43-1 of the Law, determines the admission procedure, form, program for conducting an additional examination and (or) a passing score for applicants, taking into account the specifics of the direction of training, with the exception of applicants specified in paragraphs 8 and 9 of the article 26 of the Law.

Acceptance of an application for participation in an additional exam, as well as its conduct by the University, is carried out from 01 to 20 August.

Applicants apply for participation in an additional exam at the declared University in accordance with the established scores of paragraph 3.2 of these Rules.


An applicant is enrolled in the University subject to passing an additional exam and (or) a passing threshold score established by the University.

3.5 Citizens of the Republic of Kazakhstan with technical and vocational, post-secondary or higher education are admitted to study under educational programs of higher education, which provide for reduced terms of study.

Admission of graduates of technical and professional organizations, post-secondary education with the qualification of "mid-level specialist" or "applied bachelor" in related areas of training of higher education personnel, providing for reduced terms of study, entering the paid department of full-time education and full-time education using distance learning technologies is carried out by the admission committee of the University in accordance with the order Minister of Education and Science of the Republic of Kazakhstan dated April 1, 2019 No. 134 "On determining methodological recommendations for the compliance of related groups of educational programs of higher education and specialties of technical and vocational, post-secondary education" based on the results of the interview .

3.6 Admission to the University of persons with higher education, for a group of educational programs that provide for reduced terms of study on a paid basis, is carried out by the admission committee of the University based on the results of the interview

3.7 Admission of foreign citizens to study at the University on a paid basis is carried out based on the results of an interview conducted by the admissions committee of the University during the calendar year. At the same time, foreign citizens are enrolled in accordance with the academic calendar 5 (five) days before the start of the next academic period.

At the same time, the admission of foreign citizens on the basis of an educational grant and on a paid basis is carried out by the organizations of higher and postgraduate education, who have been accredited in accordance with Article 9-1 of the Law

3.8 Upon admission to study at the University, an admission quota is provided in the amount approved by the Decree of the Government of the Republic of Kazakhstan dated February 28, 2012 No. 264 "On approval of the size of the admission quota for admission to study in educational organizations that implement educational programs of technical and vocational, post-secondary and higher education"


3.9 Admission of persons entering the University is carried out on their applications on a competitive basis in accordance with the points of the standard certificate, in the form approved by the order of the Acting Minister of Education and Science of the Republic of Kazakhstan dated October 23, 2007 No. 502 "On approval of the form of documents of strict accountability, used by educational organizations in educational activities" (registered in the Register of State Registration of Normative Legal Acts under No. 4991) and (or) an electronic certificate with unique data of the applicant, officially confirming the results of the unified national testing (UNT) published on the website of the National Testing Center (hereinafter referred to as the certificate UNT).

3.10 At the University, by the decision of the President or the person acting in his capacity, a selection committee is created. The selection committee includes the rector of the University, Vice-Rectors, Heads of structural divisions and representatives of the teaching staff of the University. The quantitative composition of the selection committee consists of an odd number of members. The chairman of the selection committee is the President of the University. By order of the President of the University, the Executive Secretary of the Admissions Committee is appointed.

At the same time, the University does not accept students in the following cases:

- 1) adoption of a decision by the authorized body on suspension, revocation and deprivation of the license and (or) annex to the license to engage in educational activities;
- 2) suspension, revocation or expiration of accreditation, with the exception of educational organizations under the President of the Republic of Kazakhstan and military, special educational institutions;
- 3) upon detection of gross violations based on the results of state control and (or) during the trial based on its results;
- 4) the absence or exclusion of the educational program from the Register of educational programs of the authorized body in the field of education for the corresponding group of educational programs.

## **4 The Procedure for Enrolling in the University for Undergraduate Programs**

4.1 For enrollment, applicants provide the University (through the admissions office) or through the web portal "Electronic Government" [www.egov.kz](http://www.egov.kz) (hereinafter referred to as the portal) a package of documents provided for in paragraph 8 of the State Service Standard "Acceptance of documents and enrollment in higher educational institutions for study in educational programs of higher education" (hereinafter referred to as the State Service Standard), in accordance with Appendix 9.

An employee of the admission committee of the University accepts a package of documents, registers them and issues a receipt to the applicant on the acceptance of a package of documents on the day of receipt of the application, or if the applicant provides an incomplete package of documents, refuses to accept documents.

In case of applying through the portal, the applicant is sent to the "personal account" the status of acceptance of the request for a public service, as well as a notification indicating the date and time of receipt of the result of the public service.

From the moment they are received, an employee of the admissions committee of the University checks the completeness of the submitted documents, in case of incompleteness, prepares a reasoned refusal to further consider the application, which is sent in the form of an electronic document to the applicant in the "personal account" on the portal.


If the applicant provides a full package of documents, the admissions committee sends a notification of acceptance of documents for admission to the University.

After receiving the notification, the applicant submits the original documents to the selection committee within the period from 10 to 25 August of the calendar year. After receiving the documents, the Rector of the University issues an order to enroll the applicant in the number of students.

Enrollment of students entering the University is carried out by the admission committee from August 10 to August 25 of the calendar year for studying in Kazakh, Russian or English, by order of the rector of the university.

4.2 Holders of a higher education educational grant at the expense of the republican or local budget, as well as tuition fees at the expense of citizens' own funds and other sources, choose an educational program from the corresponding group of educational programs. Applicants to the admissions office of the University attach to the application for admission:

- 1) a document on general secondary, technical and vocational, post-secondary or higher education (original);
- 2) identity document (required for personal identification);

3) 6 photographs 3 x 4 centimeters in size;

4) on electronic or paper media, a medical certificate in the form 075-y, approved by order of the Acting Minister of Health of the Republic of Kazakhstan dated October 30, 2020 No. KR DSM 175/2020 "On approval of accounting documentation in the field of healthcare".

5) UNT electronic certificate from the applicant's personal account on the basis of the National Testing Center;

6) an extract from the statement (for applicants for educational programs of higher education that require special and (or) creative training, including in the areas of education "Pedagogical Sciences";

7) an electronic certificate of awarding an educational grant (if any).

Persons who have documents on technical and vocational, post-secondary education, who have confirmed their qualifications and have work experience in their specialty for at least one year, additionally submit one of the following documents:

1) a copy of the work book (the original is provided for verification);

2) track record (a list of information about the work, labor activity of the employee), signed by the employer, certified by the seal of the organization (if any);

3) an archival certificate containing information about the work activity of the employee,

4) an extract from the unified accumulative pension fund on the transferred mandatory pension contributions and information from the State Social Insurance Fund on the social contributions made;


5) an employment contract marked by the employer on the date and grounds for its termination;

6) extracts from the acts of the employer confirming the emergence and termination of labor relations on the basis of the conclusion and termination of an employment contract

7) extracts from the payroll sheet for employees.

4.3 Citizens from among the disabled of groups I, II, disabled since childhood, disabled children, persons equated in benefits and guarantees to participants and disabled veterans of the Great Patriotic War, persons of Kazakh nationality who are not citizens of the Republic of Kazakhstan, orphans and children, left without parental care, as well as citizens of the Republic of Kazakhstan from among the youth, who have lost or remained without parental care until the age of majority, additionally submit documents confirming the granting of a pre-emptive right and a quota.

4.4 Persons with secondary, technical and vocational or post-secondary education, with the exception of those entering related areas of training of higher education personnel, providing for reduced training periods, who did not score a threshold score according to the results of the UNT, with the results of the UNT

with inappropriate combinations of profile subjects, with canceled UNT results are enrolled in the University for full-time education on a paid basis. During the academic year, these persons retake the UNT, including winter and summer vacations within the established time limits specified in the Rules for conducting unified national testing, approved by order of the Minister of Education and Science of the Republic of Kazakhstan dated May 2, 2017 No. 204 ((hereinafter - Order No. 204 ).

4.5 Persons who have received a certificate of awarding an educational grant at the expense of the republican budget and the local budget, which indicate the educational programs of the University, apply for admission and are enrolled in the number of students of the University by order of the rector or a person acting as his/her duties.

4.6 Holders of an educational grant of higher education for groups of educational programs requiring creative training are enrolled in which they passed creative exams.

4.7 Citizens of the Republic of Kazakhstan entering on the basis of a state grant conclude an agreement for the provision of educational services with the condition of working out for at least 3 (three) years in the manner established by the Decree of the Government of the Republic of Kazakhstan dated March 30, 2021 No. 390 "On approval of the Rules for sending a specialist to work, granting the right to self-employment, exemption from the obligation or termination of the obligation to work by citizens who studied on the basis of the state educational order, and making changes and additions to the Decree of the Government of the Republic of Kazakhstan dated January 23, 2008 No. 58 "06 Approval of the Rules for Awarding an Educational Grant".

4.8 Admission to the University is carried out separately for educational programs of higher education and language departments.

4.9 Enrollment in educational programs of higher education, for which creative exams are established, is carried out taking into account the scores for these exams.


4.10 Enrollment in the areas of education "Pedagogical Sciences" is carried out taking into account the results of a special exam.

4.11 Documents in a foreign language are provided with a notarized translation into Kazakh or Russian.

4.12 Documents on education issued by foreign educational organizations undergo the nostrification procedure in accordance with the procedure established by the legislation of the Republic of Kazakhstan after enrollment of persons during 1 (first) academic period of study.

4.13 The University, within 10 (ten) calendar days after the completion of enrollment, submit to the Ministry of Education and Science of the Republic of Kazakhstan a final report on the enrollment of applicants for educational programs.

## 5 General Provisions for Admission to Educational Programs of Magistracy and Doctoral Studies

5.1 Admission of persons to the magistracy, doctoral studies, including targeted training, is carried out on a competitive basis based on the results of comprehensive testing (hereinafter referred to as CT) or entrance exams.

Admission of foreigners to magistracy, doctoral studies and residency is carried out on a paid basis. Obtaining by foreigners on a competitive basis in accordance with the state educational order of free postgraduate education is determined by international treaties of the Republic of Kazakhstan, with the exception of the scholarship program for master's programs.

of foreign citizens to study at the university is carried out based on the results of an interview conducted by the admissions committees of the university during the calendar year. Enrollment of foreign citizens is carried out in accordance with the academic calendar 5 (five) days before the start of the next academic period.

on education issued by foreign educational organizations are recognized in the manner prescribed by law.

Documents in a foreign language are provided with a notarized translation into Kazakh or Russian.

Documents on education issued by foreign educational organizations go through the procedure of recognition of documents on education in accordance with the procedure established by the legislation of the Republic of Kazakhstan after enrollment of persons during 1 (first) academic period of study.

5.4 To receive documents and organize entrance examinations, a selection committee is created at the university. The chairman of the selection committee is the president of the university or a person acting in his capacity. The composition and functions of the admissions committee are approved by order of the president of the university or a person acting in his capacity.


For applicants to doctoral studies, the admission committee carries out:

- 1) advising applicants on the selected group of educational programs of postgraduate education, familiarization with the procedure for the entrance exam;
- 2) organization of acceptance and verification of documents of applicants;
- 3) organization of the entrance examination for groups of educational programs.

For those entering the magistracy, the admission committee carries out:

- 1) advising applicants on the selected group of educational programs of postgraduate education, familiarization with the CT procedure and / or the entrance (creative) exam;

5.5 Acceptance of applications entering the magistracy at the university is carried out by the admission committees of the organizations of higher and postgraduate education and (or) through the information system of the NTC in the following terms:

1) from June 1 to July 15 of a calendar year;

2) from 1 to 18 November of a calendar year.

Acceptance of applications for doctoral studies at the University is carried out by the admission committee of the University and (or) through the information system of the NTC in the following terms:

1) from July 3 to August 3 of a calendar year;

2) from 1 to 18 November of a calendar year.

Entrance examinations for groups of educational programs for doctoral studies are held at the following dates:

1) from 4 to 20 August of the calendar year;

2) from November 19 to December 11 of a calendar year.

When submitting documents, the applicant indicates one organizations of higher and postgraduate education and one group of educational programs.

Persons entering doctoral studies submit the following package of documents:

1) an application in any form;

2) a document on education (original, when submitting documents to the selection committee);

3) identity document (required for personal identification);

4) a certificate confirming knowledge of a foreign language:

- English Language: IELTS Academic (International English Language Testing System Academic) threshold score is not less than 5.5;

- TOEFL IBT (Test of English as a Foreign Language Internet-based test), threshold score is not less than 46;

- TOEFL PBT (Test of English as a Foreign Language Paper-based test), threshold score is not less than 453;

- TOEFL ITP (Test of English as a Foreign Language Institutional Testing Program), threshold score is not less than 460;

- German language: Deutsche Sprachprüfung für den Hochschulzugang (DSH, Niveau B 2/ level B 2), TestDaF-Prüfung (Niveau B 2/ level B 2);


- French language: TFI (Test de Français International™) – not below level 2 by \_ sections reading and listening ), DELF (Diplôme d'Études en Langue française) - level B2, DALF (Diplôme Approfondi de Langue française) - level B 2, TCF (Test de connaissance du français) - not less than 50 points ;

5) a medical certificate in the form 075 / y in electronic format, approved by order No. KR DSM-175/2020).

In cases of implementation of restrictive measures, the introduction of a state of emergency, the occurrence of emergency situations of a social, natural and man-made nature in a certain territory, a medical certificate is provided directly to the educational organization as these measures are removed;

6) six photographs 3x4 cm in size;

7) a personal sheet on personnel records or other document confirming labor activity, certified by the personnel department at the place of work;

8) a list of scientific and scientific-methodical works (scientific publications, research plan, essays and other documents) for the last 3 calendar years.

Persons with a certificate (TOEFL ITP (Test of English as a Foreign Language Institutional Testing Program) pass additional testing for knowledge of English before the entrance exam to doctoral studies.

The number of test tasks for additional testing for knowledge of the English language is 100 questions. The maximum score is 100 points.

Additional testing for knowledge of the English language is assessed in the form - "admission" or "non-admission". You must score at least 75 points in order to qualify.

Additional testing for knowledge of the English language is carried out by the NTC in organizations determined by the authorized body in the field of education.

The date, time and place of passing additional testing for knowledge of the English language are brought to the attention of applicants through their personal account.

When providing an incomplete list of documents specified in this paragraph, the selection committee does not accept documents from applicants.


Enrollment in master's and doctoral studies is carried out in the following terms:

- 1) from 15 to 28 August of the calendar year;
- 2) from December 26 to January 10 of a calendar year.

## 6. The Procedure for Enrolling in Postgraduate Educational Organizations

6.1 Enrollment of persons in the scientific and pedagogical magistracy on a paid basis is carried out based on the results of the CT in accordance with the Scale of 150-point grading system for CT in the master's program with the Kazakh or Russian language of instruction in accordance with **Appendix 2 to these Rules** (hereinafter - Appendix 9): at least 75 points, while in a foreign language - at least 25 points, according to the profile of a group of educational programs: with the choice of one correct answer - at least 7 points, with the choice of one or more correct answers - at least 7 points, according to the test for definition readiness for learning - at least 7 points.

Enrollment of persons in a specialized magistracy with Kazakh or Russian language of instruction on a paid basis is carried out based on the results of CT in accordance with the Scale of 100-point grading system for CT in a specialized magistracy with Kazakh or Russian language of instruction in accordance **with Appendix 3** to these Rules (hereinafter referred to as Annex 10): at least 50 points, while on the test for determining readiness for learning - at least 7 points, on the profile of a group of educational programs: with the choice of one correct answer -

at least 7 points, with the choice of one or several correct answers - at least 7 points.

Enrollment of persons in a specialized master's program with English as the language of instruction on a paid basis is carried out based on the results of the CT in accordance with the Scale of a 100-point grading system for CT in a profile master's program with English as the language of instruction in accordance **with Appendix 4** to these Model Rules (hereinafter - Appendix 8): at least 50 points, while on the test for determining readiness for training - at least 7 points, on the profile of a group of educational programs: with the choice of one correct answer - at least 7 points, with a choice one or more correct answers - at least 7 points.

Persons entering the magistracy are enrolled in the University on condition that they pass the passing threshold established by the University.

Enrollment of persons in doctoral studies on a paid basis is carried out on the basis of an international certificate confirming the knowledge of a foreign language in accordance with the pan-European competencies (standards) of foreign language proficiency and based on the results of an entrance exam in the profile of a group of doctoral educational programs and who scored at least 75 points out of a possible 100 points.

6.2 For training under the state educational order on a competitive basis, persons who have scored the highest scores in CT and (or) the entrance exam and (or) creative exams are enrolled:


1) for the scientific and pedagogical magistracy, including for groups of educational programs that require creative training, for groups of educational programs that require knowledge of the Arabic language - at least 75 points in accordance with Appendix 9;

2) for a profile magistracy with the Kazakh or Russian language of instruction - at least 50 points in accordance with Appendix 10;

3) for a specialized master's program with English as the language of instruction - at least 50 points in accordance with Appendix 12;

Persons who scored at least 75 points in the entrance exam are enrolled for doctoral studies under the state educational order on a competitive basis.


6.3 In the case of the same indicators of competitive scores, persons with the highest mark in the entrance exam according to the profile of the group of the educational program receive the priority right when enrolling in doctoral studies. Then, scores for essays, scores for the readiness test, scientific achievements corresponding to the profile of the educational program are taken into account: scientific publications, including those in rating scientific publications included in the 1st, 2nd quartile according to the Journal Citation Reports of the company's Web of science database Clarivate Analytics for the last 3 calendar years; certificates of scientific developments; certificates of awarding scientific scholarships, grants; certificates/diplomas for participation in scientific conferences and competitions.

6.4 Unused places under the state educational order for doctoral studies, including targeted ones, are returned to the authorized bodies in the field of education, health care and culture in the form of an application for further redistribution between the organizations of higher and postgraduate education in the context of groups of educational programs of postgraduate education until September 5 of the calendar year.

6.5 The University submits to the authorized bodies in the field of education, health and culture within 10 calendar days a final report on the organization and conduct of admission, as well as copies of orders for admission to the magistracy and doctoral studies under the state educational order.
